1. Please share a brief overview of yourself:

- 7. Provide an overview of your Kairos experience. I first supported Kairos Men's Inside by attending many of the closing ceremonies. I later got involved with Torch and served as an assistant table leader, later I became a table leader. I start by as Fundraising co-ordinator as well as Financial Secretary/Donor Co-ordinator within the AC. From there I became Vice-Chair and finally Chair. In total I served for a period of six years within Torch. I have also attended a number of AKT sessions over the years. I have only attended Women's Outside closing as my commitment was with Torch.
